The North American Energy Standards Board ("NAESB") voluntarily submits this report to the Federal Energy Regulatory Commission ("FERC" or "Commission") regarding the Parallel Flow Visualization ("PFV") project. PFV is an effort to improve the congestion management process of the Eastern Interconnection by increasing the real-time visibility of the source and magnitude of bulk electric system parallel flows in the Interchange Distribution Calculator ("IDC") tool. The project is a coordinated effort between NAESB, the North American Electric Reliability Corporation ("NERC") and the Interchange Distribution Calculator Association ("IDC Association"). This report is intended for informational purposes and serves to provide the Commission with updated information concerning the progress within NAESB to develop Wholesale Electric Quadrant ("WEQ") Business Practice Standards to support the PFV effort.

As indicated in the informational report filed by NAESB on July 11, 2014, NAESB will continue to file periodic status reports with the Commission throughout the project to inform the Commission of the progress of the standards development and the testing of those standards. Upon completion of the field test and ratification of the standards, NAESB will file a report with the Commission containing the final version of the NAESB WEQ Business Practice Standards for the PFV effort.

REPORT OF THE NORTH AMERICAN ENERGY STANDARDS BOARD

The North American Energy Standards Board ("NAESB") is voluntarily submitting this report to provide the Commission with a status update the Parallel Flow Visualization ("PFV") project. The PFV project is an industry-led effort seeking to provide an enhanced congestion management process within the Eastern Interconnection by improving the real-time visibility of the source and magnitude of bulk electric system parallel flows in the Interchange Distribution Calculator ("IDC") congestion management tool. In recognition of the interrelated nature and complexities of the PFV project, NAESB, the North American Electric Reliability Corporation ("NERC") and the Interchange Distribution Calculator Association ("IDC Association") are engaged in continued coordination activities to support a successful completion of the project. Under these coordination efforts, NAESB is responsible for developing business practice standards that support the PFV effort. A recommendation containing the proposed standards has been completed by the NAESB WEQ Business Practices Subcommittee ("BPS") and was presented to the NAESB WEQ Executive Committee ("EC") during its October 21, 2014 meeting. During the meeting, the NAESB WEQ EC opted to delay a vote on a recommendation to allow for the development of additional revisions to address issues raised by the formal comments submitted by the industry and through discussions during its meeting. A revised recommendation has been distributed for formal comment and will be considered during the February 24, 2015 WEQ EC meeting. This filing is intended to provide the Commission with information on the current status of the standards development effort within NAESB and is meant to supplement the information contained in the initial status report filed on July 11, 2014.

Accompanying this filing are six appendices related to the PFV project. Appendix A contains a link to the October 21, 2014 WEQ EC meeting minutes and a listing of the available transcripts. Appendices B and C provide links to the meeting notes, comments, work papers and voting records of the WEQ EC PFV Task Force and WEQ BPS respectively. Appendix D is a description of the NAESB process to develop and adopt standards. Appendix E provides the NAESB 2014 WEQ Annual Plan, and Appendix F provides the NAESB 2015 WEQ Annual Plan.

The PFV project is an industry initiated effort seeking to improve upon the Transmission Loading Relief ("TLR") process by increasing the visualization of the current operating state of the bulk electric system, allowing reliability coordinators within the Eastern Interconnection to better assign more representative relief obligations during periods of congestion. The standard modifications proposed as part of the PFV effort will provide additional clarity as to how transactions are curtailed. Additionally, the revisions further assist the curtailment of non-firm intra-balancing authority transmission service prior to the curtail of firm transmission service by addressing the default assumption that all generators within the Eastern Interconnection have firm transmission service and by supporting the near real-time reporting of data to the IDC, a tool utilized by the Eastern Interconnection as part of the congestion management process. Once completed, the PFV project should support the Commission's directives

regarding increased curtailment transparency as stated in FERC Order No. 890 as well as the Commission's policy on the curtailment of transmission service as noted in sections 13.6 and 14.7 of the *pro forma* OATT.

As part of the PFV effort, NAESB is facilitating the development of modifications to the NAESB WEQ-008 Transmission Loading Relief - Eastern Interconnection Business Practice Standards. NAESB tasked the NAESB WEQ BPS with the standards development process for this effort, and the subcommittee began regularly holding meetings on this topic beginning in June 2009. The subcommittee completed work on a recommendation in September 2014. During this time period, the NAESB WEQ BPS met 70 times to discuss and develop the recommendation and held two informal comment periods soliciting industry feedback on the proposed standards. The revisions to the standards propose that a balancing authority must elect one of two different methods for assigning curtailment priorities, either the Tag Secondary Network Transmission Service Method or the Generator Prioritization Method. Under the Tag Secondary Network Transmission Service Method, electronic tagging (e-Tag) requirements will be expanded beyond inter-balancing authority transactions to incorporate intra-balancing authority transactions, including transactions classified as pseudo-ties. The e-Tags will then be used to establish the curtailment priority. The Generator Prioritization Method utilizes a generator priority schedule detailing the firm and non-firm transmission priorities of each generator to determine the assignment of curtailments. Regardless of the method chosen, the determination of transmission priorities must be consistent with the transmission service provider's tariff. Additionally, the proposed standards recognize the use of seams agreements as part of the congestion management process by allowing the transmission priority established by the seams agreement to replace the priority determined by the IDC calculations. Entities with a seams agreement(s) incorporated into their tariffs or other governing documents may submit overrides of transmission priorities to the IDC for the flowgate(s) identified as part of the seams agreement(s). The subcommittee made this accommodation at the request of the industry.

On September 4, 2014, a thirty-day formal comment period for the subcommittee's recommendation on proposed revisions to the standards was initiated. The NAESB office received five sets of formal comments submitted by the TVA, MISO, Southern Company, Xcel Energy, and joint comments submitted by IESO, ISO New England, New York ISO, PJM and Southwest Power Pool on behalf of the ISO/RTO Council. The comments submitted by TVA raised several concerns primarily regarding the treatment of seams agreements and pseudo-ties within the standards. MISO's comments supported moving forward with the recommendation and holding the standards in abeyance for the duration of the field test in the event that further modifications to the standards are needed. The comments submitted by Southern Company voiced opposition to the recommendation, stating that the proposed standards do not make significant improvements upon the lack of visualization of parallel flows within the Eastern Interconnection and objecting to the manner in which seams agreements and pseudo-ties are treated within The comments submitted by Xcel Energy expressed general support for the the proposed standards. recommendation. The joint comments submitted on behalf of the ISO/RTO Council recognized that there were several issues documented by the subcommittee that needed to be resolved before the standards were finalized but supported moving forward with the field test while holding the standards in abeyance. Based on the formal comments, the NAESB WEQ BPS developed a set of late comments proposing modifications to the recommendation. Additional late formal comments were submitted by the WEQ Standards Review Subcommittee, proposing grammatical modifications and changes for consistency, and by TVA, reiterating its position on the treatment of seams agreements and proposing alternative standards language.

On October 21, 2014, the NAESB WEQ EC met to review the recommendation, the five sets of formal comments, and the three sets of late formal comments. The recommendation and resulting comments were the primary topic of discussion during the meeting. While a few NAESB WEQ EC members supported moving the recommendation forward to the full-staffing and testing phase, it became apparent that a significant number of NAESB WEQ EC members opposed the recommendation in its current iteration. Several participants raised concerns about the requirements surrounding seams agreements within the proposed standards, noting that the language was vague and could create unintentional advantages that might produce inequitable outcomes or negatively impact third parties by increasing the flow of firm service on their systems. Other concerns raised during the meeting related to treatment of pseudo-ties and the need for increased transparency within the proposed standards regarding the determination of firm and non-firm generation. Additionally, some participants stated that the proposed standards contained within the recommendation were not needed as problems related to parallel flows were only perceived issues. Others claimed that since the time NAESB initiated its PFV effort, any tangible issues related to parallel flows had been resolved by the additional congestion management processes and programs developed by the industry, specifically market-to-market redispatch. These participants recommended that before NAESB take any action, including the approval of standards, the IDC Association conduct comprehensive testing on the modifications to the IDC currently underway to determine if there are current issues in the industry related to parallel flows.

During the discussions, a concern was raised that due to the number of issues raised by the formal comments, the recommendation might not be ready for consideration by the NAESB WEQ EC. However, it was noted that there appeared to be general support to craft proposed revisions to the recommendation to address the discussed issues. In response, the chair of the NAESB WEQ EC created the NAESB WEQ EC PFV Task Force, charged with proposing redlined modifications to the recommendation to address concerns regarding generator prioritization, seams agreements, and other issues limited in scope to the formal and late comments submitted to the NAESB WEQ EC for the recommendation. As agreed to by the NAESB WEQ EC members, the task force utilized a version of the draft standards incorporating the late formal comments submitted by the NAESB WEQ BPS as its baseline for developing the proposed revisions. The proposed revisions of the subcommittee mainly address grammatical errors or changes for consistency are based on the subcommittee's review of the formal comments prior to the NAESB WEQ EC meeting on October 21, 2014.

The NAESB WEQ EC PFV Task Force held its initial meeting on November 3, 2014. Following this meeting, the task force held one additional meeting in November, three meetings in December, and two meetings in January. At its meeting on January 12, 2015, the task force voted to approve a recommendation containing proposed revisions meant to address the issues raised during the formal comment period. Over thirty individuals representing approximately fifteen different entities participated in meetings of the task force, with representatives from Duke Energy, Georgia Transmission Corporation, Manitoba Hydro, MISO, New York ISO, North Carolina Electric Membership Corporation, Southern Company, Southwest Power Pool, and TVA all voting in favor of the

recommendation containing the proposed modifications. A thirty day, formal industry comment period for the recommendation began on January 12, 2015 and will end on February 10, 2015. The NAESB WEQ EC PFV Task Force will meet on February 12, 2015 to review any formal comments. The recommendation, any received formal comments, and the late comments of the task force, if applicable, will be presented to the NAESB WEQ EC for consideration during its meeting on February 24, 2015.

NAESB filed an initial report with the Commission regarding the PFV effort on July 11, 2014. The report was written in coordination with NERC and the IDC Association and included a history of the PFV effort, a description of the ongoing and upcoming coordination activities between NAESB, NERC, and the IDC Association, and an overview of the future of the project. As stated in the report, NAESB is in the process of developing business practice standards to support the PFV project and that complement NERC Reliability Standards. NAESB will utilize the full-staffing process for this standards development effort, meaning that after the standards are approved by the NAESB WEQ EC, they will not be immediately ratified by NAESB WEQ membership but rather held in abeyance while the IDC Association conducts a field test on the standards. This will allow for any needed modifications to the standards to be made prior to, during, or following the field test. The IDC Association will be responsible for conducting the field test, including the development of a test plan, and has indicated it will require the input of both the NAESB WEQ BPS and the NERC Operating Reliability Subcommittee ("ORS") in the development of commercial and reliability metrics for the field test. The preparation period for the field test is expected to be between twelve and eighteen months in duration while the required changes to the IDC tool to accommodate PFV related revisions to the NAESB standards are identified and implemented. This preparation period will begin as soon as the NAESB WEQ EC has taken action to approve the proposed, PFV related revisions to the business practice standards. After the test preparations have been made, the field test is expected to last between twelve and eighteen months. During the field test, the IDC tool will continue normal operations and testing on the PFV-related standards will be conducted in a parallel environment. Following the conclusion of the field test the IDC Association will provide a report to NAESB identifying the results of the field test with respect to the commercial metrics for evaluation. If necessary, NAESB will make any needed modifications to the business practice standards. NAESB, the NERC Operating Reliability Subcommittee, and the IDC Association will work together to identify and correct any resulting unintended, negative reliability impacts that may occur. After any necessary modifications are made to the standards, a recommendation on the standards will be re-presented to the NAESB WEQ EC for consideration. If the recommendation garners super majority support, it will be forwarded to the NAESB WEQ membership for ratification. NAESB will then file the ratified standards with the Commission.

Following the February 24, 2015 NAESB WEQ EC meeting, where the proposed revisions to the standards put forth by the NAESB WEQ EC PFV Task Force will be presented, NAESB will provide the Commission with another status update regarding the actions of the NAESB WEQ EC.

Appendix D: NAESB Process to Develop and Adopt Standards
January 28, 2015

The NAESB Standards Development Process

NAESB is focused on proposing, considering, and adopting voluntary standards and model business practices that will have a significant and lasting impact on all aspects of the natural gas and electricity marketplaces. As a result of the standards NAESB adopts, it is expected that the industry will operate more efficiently and effectively, benefiting both the industry and its customers. At the same time, it must be acknowledged that NAESB standards may constitute a change in the way parties do business, with an accompanying effect on the use and allocation of resources.

NAESB's policy is to move at a deliberate pace, consistent with its annual plan(s), thus permitting those affected by its standards, especially those standards adopted as regulations by the Federal Energy Regulatory Commission (FERC) or other regulatory bodies, to assimilate them as part of their business practices. To this end, NAESB will carefully consider whether proposed standards are both timely and necessary. In particular, it will try to avoid adopting and implementing new standards, however beneficial, before the industry is able to reasonably make use of them.

The standards development process is governed by the annual plan, and items can be included in the plan or modified only with Board approval. The plan typically reflects requests from NAESB members, government agencies, and other interested parties. In approving the annual plan, the Board considers the availability of resources, including the NAESB budget and staff and the availability of industry volunteers. New requests received throughout the year are either considered part of the existing annual plan or as new items that require Board approval.

The standards development process begins with an annual plan item or a triaged and approved request. Triage is a process used by each quadrant of the Executive Committee (EC) to determine whether a request is within scope, which quadrant(s) it applies to, which subcommittee(s) it should be referred to, and what priority it should be assigned. Triage is carried out by EC members appointed by the EC chair. Triage recommendations are submitted to the en banc EC and require EC approval, and may also require Board approval if there are scope questions or if a modification of the annual plan is required.

Once the triage process is completed, the subcommittees—more than one are normally involved in standards recommendations—review the request, compare it to existing standards, and prepare recommendations that may take the form of new or modified standards or interpretations. Participation in EC subcommittees is open to any interested party regardless of membership status. All subcommittee participants may vote; voting is balanced by segment and quadrant. All votes are public.


When the recommendation is complete, it is made available for a thirty-day industry comment period. The recommendation and comments are then forwarded to the EC, which considers the recommendation, makes any changes it deems necessary, and takes a vote. A recommendation must receive an affirmative vote of at least 67 percent from each applicable quadrant EC and 40 percent from each of the segments of the applicable quadrant(s).

After passage by the EC, the recommendation must be ratified by the NAESB members. An affirmative vote of 67 percent of the members of the applicable quadrant(s) is required for ratification. After ratification, standards and modifications are considered final actions and will be published in the next version of NAESB standards.

All NAESB quadrants follow the same development process described herein. The process has been followed by the WGQ since 1994 and has been used to develop more than five hundred standards that have been incorporated by reference into federal regulations.

Flexibility

NAESB recognizes that flexibility is necessary as standards are developed to address regional concerns or to incorporate variances to accommodate operational or structural differences. Several WEQ standards incorporate regional or operational differences for both Version 0 and Version 1. There is a high threshold for incorporating such variances in a standard; the subcommittee(s) in drafting the standard, the EC in approving the subcommittee recommendation, and the membership in approving the standard must all agree that such variance is necessary. Nonetheless, NAESB procedures are well suited to take into account operational and regional differences.

Transparency

All NAESB meetings are open for attendance and participation by any interested party, with the exception of executive sessions of the Board or Managing Committee for purposes of discussing personnel, compensation or legal issues. Meeting announcements and agendas are posted in advance to permit the widest possible participation. Conference-calling capability is available for all meetings and web casting is available for most. Those intending to attend a meeting in person or by telephone are asked to notify NAESB by a specific date to permit adequate meeting planning.

Transcripts are made of all Board of Directors and EC meetings, and may also be made of other meetings that are expected to be controversial. Transcripts are maintained in the NAESB office and are provided to regulatory agencies for their internal use. All other interested parties can purchase transcripts from the relevant transcription service.

Coordination with NERC

For business practice standards development for the WEQ, if it is determined by NERC and NAESB Executive Management that joint development is needed by NERC and NAESB, the NERC-NAESB Coordination Joint Development Process is implemented. This process requires that the appropriate NAESB Subcommittee and NERC Standards drafting team work together to develop reliability standards and business practices.

The Joint Interface Committee of NAESB, NERC and the ISO-RTO Council ("JIC") was dissolved as part of the agreement to create the Independent Grid Operator segment of the WEQ. The joint development process between NAESB and NERC is being used to ensure appropriate coordination. The ISOs and RTOs have strong decision-making roles in both NERC and NAESB, and thus with the use of the joint development process, the JIC was no longer necessary.

Accessibility of Standards and Work Products

The NAESB standards and protected work products are accessible to members at no cost as a benefit of their membership. Non-members can purchase the standards as a full version, or they can purchase individual final actions. Non-members can also access the standards at no cost by requesting an evaluation copy. NAESB standards and protected work products are copyrighted. Non-members can download a NAESB materials order form from the NAESB web site for ordering standards or for instructions on accessing standards for evaluation.




