4. SUPPORTING DOCUMENTATION

a. Description of Request:

Requested that the Stand Alone Terms data element be added to the 840 Offer Download dataset with a usage of 'C' [conditional] and add the code 'ADD' for 'Not a Stand Alone Offer Terms and Conditions' to the NTE segment.

b. Description of Recommendation:

Business Practices Subcommittee

A motion was made to recommend that “not stand alone offers terms and conditions” have its own data field and that that information be communicated separately from “special terms and conditions” data field in all related capacity release transactions, with a usage code of conditional for the new data element. This new text field is conditional based upon the data element “stand alone offer indicator” with the value of “no”.

Motion was made to move to Information Requirements Subcommittee with no specification of an implementation date.

Decided not to address issue as to inclusion of "Not a Stand-Alone Bid Terms and Conditions" in the UPPD and related datasets as this represents a BPS issue and was not part of the request. If someone desires this addition, they can present a request to BPS for disussion. However IR will recommend implementation in a manner to allow this is the future if requested and approved.]

Motion: Implement above (implementation plan from August 18, 1997 IR meeting) technically so that "Not a stand alone bid terms and conditions" can be included in either an 864 or NTE segment. Add a new Message Type code value to correspond to Not a stand alone bid terms and conditions. This code value should be different from the code value corresponding to Not a stand alone offer terms and conditions.
