### NAESB GAS ELECTRIC COORDINATION WEB CAST COURSE

As you may know, the Federal Energy Regulatory Commission (“FERC” or “Commission”) took action on April 16, 2015 through FERC Order No. 809 (Docket No. RM14-2-00) on certain proposed NAESB Wholesale Gas Quadrant standards developed in response to the FERC Notice of Proposed Rulemaking (“NOPR”) on the Coordination of the Scheduling Processes of Interstate Natural Gas Pipelines and Public Utilities. The NAESB Gas Electric Coordination Web Cast Course is designed to provide an overview of the standards developed in response to the NOPR and adopted in the final order, and will highlight the next steps NAESB intends to take to support the Commission action. The overview will include:

- A review of the actions of NAESB Board of Directors and Gas Electric Harmonization Forum in Response to the NOPR
- A review of the subsequent standards development effort that resulted in the modified standards submitted to the Commission on September 29, 2014
- A description of the next steps NAESB may take to support FERC Order No. 809, including the submission of minor corrections to reincorporate standards that define the start of the gas day and to support consistent implementation by the industry
- Other Actions to be undertaken by NAESB in response to FERC Order No. 809
