### NAESB WEQ BUSINESS PRACTICE STANDARDS, VERSION 003.1 WEB CAST COURSE

As you may know, the Federal Energy Regulatory Commission (“FERC” or “Commission”) issued a Notice of Proposed Rulemaking (NOPR), *Standards for Business Practices and Communication Protocols for Public Utilities*, in Docket No. RM05-5-025 on July 21, 2016. The NOPR proposes to revise the Commission’s regulations to incorporate by reference, with certain exceptions, Version 003.1 of the NAESB Wholesale Electric Quadrant (WEQ) Business Practice Standards. Version 003.1 was published by NAESB on September 30, 2015 and was submitted to the Commission through an informational report on October 26, 2015. The NAESB WEQ Business Practice Standards, Version 003.1 Web Cast Course is designed to provide an overview of the updates and changes made in Version 003.1 of the NAESB Business Practice Standards for the Wholesale Electric Quadrant and included in the NOPR. The overview will include:

- A review of the revisions made to the NAESB OASIS standards at the request of the industry and the Commission (WEQ-001, WEQ-002, WEQ-003 and WEQ-013)
- A review of revisions made to standards that complement the NERC Reliability Standards and activities, including a review of the new NAESB standards that support the Electric Industry Registry (WEQ-022)
- A review of revisions made to the NAESB Public Key Infrastructure standards that support cybersecurity (WEQ-012)
